BE IT FURTHER RESOLVED, that the City's Chief Financial Officer or his designee is authorized to appropriate, transfer, and expend for each BID Fund the assessment revenues in accordance with the approved FY2013 Budget Reports, which include Fund Balance and Interest Fund Balance from FY2012 at year end and the anticipated BID assessments to be collected in FY2013, and which are to be used for administration and operation of each BID in accordance with the approved FY2013 Budget Reports and with Council Policy 900-07 (Business Improvement Districts).
