A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE AWARD TO TC
CONSTRUCTION, INC. FOR THE DESIGN AND
CONSTRUCTION OF THE ALVARADO TRUNK SEWER
PHASE IIIA PROJECT; AND TAKING RELATED ACTIONS.

WHEREAS, Alvarado Trunk Sewer Phase IIIA (Project) is part of City of San Diego's
Sewer Main Replacement and Rehabilitation Program as mandated by the Environmental
Protection Agency; and

WHEREAS, this Project is located in the Navajo Community Plan area, and includes
design and construction work for the replacement of approximately 1,000 linear feet of sewer
main and all other work and appurtenances; and


WHEREAS, TC Construction, Inc. was selected as the most qualified firm following a
competitive selection process to provide design-build services; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his
designee, is authorized to execute a contract with TC Construction, Inc. for the design and
construction of the Project, for an amount not to exceed \$3,775,646.00, contingent upon the
Chief Financial Officer first furnishing one or more certificates demonstrating that funds
necessary for expenditure are, or will be, on deposit in the City Treasury.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend
funds in an amount not to exceed \$3,775,646.00 from CIP A-JB.00001, Annual Allocation –
MWWD Trunk Sewers (B-11112, Alvarado Trunk Sewer Phase IIIA), Fund 700008, Sewer

solely and exclusively to provide funds for design, construction, contingency, and related project costs.
