A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDING TO PAZZAZ INC., O'FARRELL COMMUNITY SCHOOL, SAN DIEGO MASTER CHORALE, EBEEC, AND UAAMAC, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, entitled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by Resolution R-306903; and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural or recreational needs which serve a lawful public purpose; and

WHEREAS, the following organizations have requested funding for the following purposes:

PAZZAZ, INC.	Soap Box Derby	After-school enrichment programs to keep children safe and supervised
O'Farrell Community School	Efficacy Community Street Art Project	Project designed to increase graduation rates and college preparation/ attendance
Eugene Bowman Economic Empowerment Center, Inc. (EBEEC)	Girl Talk Program to develop young girls sense of identity and make healthy life choices	Helps connect and strengthen community members and finds solutions to bullying
San Diego Master Chorale	Outreach and Collaborative Choir Concert with Lincoln High School	Joint concert at reduced prices for opportunity to introduce high level of performance to underserved community
United African American Ministerial Action Council (UAAMAC)	Public Awareness Campaign to reduce obesity/chronic illness	Reduce incidence of obesity in Southeastern San Diego community and to support healthier lifestyles

WHEREAS, it is the determination of the City Council that the above-described programs fit within the parameters of Council Policy 100-06, Community Projects, Programs and Services; and

WHEREAS, Council District Four recommends the following allocations for the purposes set forth herein:

PAZZAZ, INC.	\$5,000
O'Farrell Community School	\$4,800
Eugene Bowman Economic Empowerment Center, Inc. (EBEEC)	\$1,930
San Diego Master Chorale	\$3,200
United African American Ministerial Action Council (UAAMAC)	\$15,000

; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, that the allocations described herein are made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to negotiate and execute for and on behalf of the City, Agreements with (1) PAZZAZ, INC. in an amount not to exceed \$5,000; (2) O'Farrell Community School in an amount not to exceed \$4,800; (3) Eugene Bowman Economic Empowerment Center, Inc. in an amount not to exceed \$1,930; (4) San Diego Master Chorale in an amount not to exceed \$3,200; and (5) United African American Ministerial Action Council in an amount not to exceed \$15,000, for the projects described herein.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend the amounts described herein from the Community Projects, Programs and Services budget Fund No. 100000, Cost Center 1104110004, to provide funds for the above-referenced agreements,

contingent upon the City Comptroller first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
