BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to negotiate and execute for and on behalf of the City, Agreements with (1) PAZZAZ, INC. in an amount not to exceed \$5,000; (2) O'Farrell Community School in an amount not to exceed \$4,800; (3) Eugene Bowman Economic Empowerment Center, Inc. in an amount not to exceed \$1,930; (4) San Diego Master Chorale in an amount not to exceed \$3,200; and (5) United African American Ministerial Action Council in an amount not to exceed \$15,000, for the projects described herein.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend the amounts described herein from the Community Projects, Programs and Services budget Fund No. 100000, Cost Center 1104110004, to provide funds for the above-referenced agreements,

contingent upon the City Comptroller first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
