A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$11,500 TO HEART & HANDS WORKING TOGETHER FOR SAN YSIDRO CLEAN UP PROGRAMS, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, entitled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by Resolution R-306903; and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural or recreational needs which serve a lawful public purpose; and

WHEREAS, Heart & Hands Working Together (Heart & Hands) has requested funding to support the San Ysidro Clean Up Programs and for providing food and clothing to at-risk families in the community; and

WHEREAS, the requested funding will allow Heart & Hands to purchase a four passenger electric cart and trailer to assist with the clean up program and to transport food and supplies from the storage area to the monthly distribution area; and

WHEREAS, the allocation to these programs will enable Heart & Hands to provide food, shoes and clothing to the underserved and at-risk individuals and families and thereby create a safer community and contribute to environmental benefits to the entire community; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06, Community Projects, Programs and Services; and

WHEREAS, Council District Eight recommends an allocation of \$11,500 to Heart & Hands for the purposes set forth herein; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described herein is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to negotiate and execute for and on behalf of the City, an Agreement with Heart & Hands Working Together in an amount not to exceed \$11,500 for the project described herein.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$11,500 from the Community Projects, Programs and Services budget Fund No. 100000, Cost Center 1108110008, to provide funds for the above-referenced agreement, contingent upon the City Comptroller first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
