RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE YEAR-END REVISIONS TO THE FISCAL YEAR 2012 BUDGET OF THE CITY OF SAN DIEGO.

WHEREAS, on June 6, 2011, the Council of the City of San Diego adopted Resolution No. R-306836 approving the Fiscal Year 2012 Budget; and

WHEREAS, on July 25, 2011, the Council of the City of San Diego adopted Ordinance No. O-20073 entitled "An Ordinance Adopting the Annual Budget for the Fiscal Year 2012 and Appropriating the Necessary Money to Operate the City of San Diego for said Fiscal Year"; and

WHEREAS, on March 14, 2012, the Council of the City of San Diego adopted Resolution No. R-307312 authorizing the Chief Financial Officer to amend the Fiscal Year 2012 Budget in accordance with the Fiscal Year 2012 Mid-Year Budget Monitoring Report No. 12-018 [Mid-Year Report]; and

WHEREAS, the amendments in the Mid-Year Report resulted in an increase to General Fund expenditure appropriations by \$9,842,000 from additional revenues and \$5,000,000 from the projected surplus; and

WHEREAS, the Mayor has now proposed to revise the Fiscal Year 2012 budget as presented in the Fiscal Year 2012 Year-End Budget Monitoring Report No. 12-068 (Year-End Report); and

WHEREAS, the Year-End Report also identifies departments and projects where the appropriations for the current year have proven insufficient; and

WHEREAS, the Appropriation Ordinance No. O-20073 section 15 authorizes the Chief Financial Officer to modify appropriations upon adopted City Council resolution; and

WHEREAS, the City Council desires to approve the budget revisions as proposed by the Mayor; NOW, THEREFORE;

BE IT RESOLVED, by the Council of the City of San Diego that the Chief Financial Officer is authorized to amend the Fiscal Year 2012 Budget, in accordance with Year-End Report, as follows:

- a. Increase General Fund (100000) expenditure appropriations and revenue budget by up to \$597,000 as follows:
 - 1. Increase the Fire-Rescue (1912) expenditure appropriations by up to \$502,000,
 - 2. Increase the Office of the Assistant Chief Operating Officer (1300) expenditure appropriations by up to \$5,000,
 - 3. Increase the Council Administration (1151) expenditure appropriations by up to \$90,000,
 - 4. Increase the Major Revenues (9911) revenue appropriations by up to \$597,000.
- b. Increase the Fire/Emergency Medical Services (EMS) Transportation Program

 Fund (200227) expenditure appropriations by up to \$241,000 from \$133,000 in
 additional revenues and \$108,000 of available fund balance,
- c. Increase the Los Peñasquitos Canyon Preserve Fund (200303) expenditure appropriations by up to \$3,000 from additional revenues,
- d. Increase the Transient Occupancy Tax Fund (TOT) (200205) expenditure appropriations by the amount equal to actual revenue received at year end,

- e. Reduce the Proposition 42-Transportaiton Relief Fund (200306) expenditure appropriations by up to \$5,297,741.57,
- f. Appropriate all of the remaining fund balance in the ERP Capital Project (400020), and ERP (200310) Funds and transfer the balances to the OneSD Support Fund (200610), in order to close the ERP Capital Project (400020) and ERP (200310) funds.
- g. Transfer \$90,000 from the General Fund (100000), Council Administration (1151) to the General Fund Contributions to the CIP Fund (400265) for City Facilities Improvements (ABT00001) CIP project.
- h. Reduce the Fiscal Year 2012 Capital Improvement Program (CIP) budget by approximately \$152.6 million as follows:
 - Close the projects listed on Attachment I and transfer unexpended balances to the appropriate Unallocated Reserve or Fund Balance as a result of the closure; and
 - De-appropriate \$104,104,652.53 from the Water Utility CIP Fund
 (700010) and \$12,000,000.00 from the Municipal Sewer Revenue CIP
 Fund (700008) from the specific projects as listed on Attachment II, and
 - 3. De-appropriate \$12,676,708.31 from the Capital Outlay Fund (400002), in the City Facilities Improvements (ABT00001).
 - Increase appropriations and expend \$90,000 in City Facilities
 Improvements (ABT00001) from the General Contributions to the CIP
 Fund (400265).

BE IT FURTHER RESOLVED, by the Council of the City of San Diego that the Chief Financial Officer is authorized to transfer appropriations between General Fund (100000) departments as necessary where the net transfer does not result in an increase to either departments current budget, and

BE IT FURTHER RESOLVED, by the Council of the City of San Diego that the Chief Financial Officer is authorized to transfer appropriations among General Fund (100000) departments as necessary at fiscal year close to match actual activity, and

BE IT FURTHER RESOLVED, by the Council of the City of San Diego that the Chief Financial Officer is authorized to adjust appropriations for unforeseen events in order to close Fiscal Year 2012 with departments and funds in balance.
