BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to issue a task order(s) with a minimum aggregate value to exceed \$1,000 from WBS B-00974, Western Police Station Roof Replacement Project, Fund 400624, for the purpose of executing this agreement and meeting minimum contract requirements.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$2,000,000 for the purpose of funding the as-needed civil engineering services agreement with RBF Consultants contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds are, or will be, on deposit with the City Treasury.

BE IT FURTHER RESOLVED, that prior to the award of each task order under the Agreement, the Chief Financial Officer must first provide one or more certificates demonstrating that the necessary funds are, or will be, on deposit in the City Treasury.
