A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING GRANT APPLICATION
SUBMITTALS FOR MISSION BEACH SEAWALL
FEASIBILITY STUDY AND DESIGN.

WHEREAS, on November 7, 2006, the voters of California approved Proposition 84, the “Safe Drinking water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act of 2006;” and

WHEREAS, Proposition 84 is a \$5,400,000,000 bond measure for a wide variety of projects related to water safety, rivers, beaches, levees, watersheds, parks, and forests; and

WHEREAS, the passage of Proposition 84 included Section 75032 of the California Public Resources Code which states that \$275,000,000 will be available to the California Department of Water Resources; and

WHEREAS, through Proposition 84 the Local Levee Critical Repair (LLCR) strategy and the Local Levee Evaluation (LOLE) strategy of the Local Levee Assistance Program (LLAP) were created; and

WHEREAS, the Mission Beach Seawall Feasibility (Study project) fully meets the intent of the LLAP LOLE strategy of assisting local flood management agencies with the funding necessary to conduct surveys, hydrology and hydraulic studies, and geotechnical evaluations of flood control facilities that are at risk of failing; and

WHEREAS, the Mission Beach Seawall Design (Design Project) fully meets the intent of the LLAP LLCR strategy of assisting local flood management agencies with the repair of local

flood control facilities, including but not limited to critically erosion-damaged levees, levees with unstable slopes, and other unstable flood control facilities; and

WHEREAS, the Mission Beach Seawall is an approximate 12,500 feet long seawall and walkway bulkhead structure, and it reaches from its southern limits at Mission Beach Jetty to Thomas Avenue; and

WHEREAS, the walls along all sections of the boardwalk have suffered varying levels of distress and repairs were done in 1989, 1998 and 2003; nevertheless, deterioration continued, and was especially evident in the bulkhead constructed in 1925 and 1928; and

WHEREAS, the bulkhead is used as a form of coastal management which was built for the purpose of preventing sand erosion and water flooding of the nearby private properties; and

WHEREAS, the Study Project will conduct a study of the integrity of the existing Mission Beach Seawall which includes evaluation of the concrete pile walls, continuous concrete pile cap, parapet walls and concrete walkway for the Mission Beach Seawall from the southern limits at south Mission Beach Jetty to Thomas Avenue, a distance of approximately 2.4 miles; and

WHEREAS, the Design Project will include preparation of construction documents, a construction cost estimate and project management; and

WHEREAS, the project will design elements recommended for improvements by the study of the existing Mission Beach Seawall; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego as follows:

1. That the Mayor or his representative is authorized to make two applications to the State of California for an amount not to exceed \$50,000 in Local Levee Assistance Program-Local Levee Evaluation strategy grant funds for the completion of the Mission Beach Seawall

Feasibility Study and an amount not to exceed \$600,000 in Local Levee Assistance Program-Local Levee Critical Repair strategy grant funds for the completion of the Mission Seawall Design project.

2. That the Mayor or his representative is authorized to take all necessary actions to secure funding from the State of California for the completion of the Mission Beach Seawall Feasibility Study and Mission Beach Seawall Design.

3. That the Chief Financial Officer as delegated to Financial Management is authorized to accept, appropriate, and expend funds, if grant funding is secured.

4. That the Chief Financial Officer is authorized to establish a special interest bearing account for the grant funds.

5. That the Chief Financial Officer is authorized to increase the Fiscal Year 2013 Capital Improvement Program Budget in CIP No. S-00726 (Mission Beach Boardwalk Bulkhead) in an amount not to exceed \$50,000 for the Mission Beach Seawall Feasibility Study (600001/1000373-2012) and an amount not to exceed \$600,000 for the completion of the Mission Beach Seawall Design project (600001/1000374-2012), contingent upon receipt of a fully executed grant agreement(s).

6. That the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$50,000 from CIP No. S-00726 (Mission Beach Boardwalk Bulkhead) for the Mission Beach Seawall Feasibility Study (600001/1000373-2012) and an amount not to exceed \$600,000 from CIP No. S-00726 (Mission Beach Boardwalk Bulkhead) for the completion of the Mission Beach Seawall Design project (600001/1000374-2012), contingent upon receipt of a fully executed grant agreement(s).

7. That the Mayor or his delegated representative is authorized to conduct all negotiations, sign and submit all documents, including, but not limited to applications, agreements, amendments, and payment requests, which may be necessary for the completion of the Study Project and Design Project.
