A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$8,300 TO THE ED BROWN SENIOR CENTER AT RANCHO BERNARDO PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, entitled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by Resolution No. R-306903; and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural or recreational needs which serve a lawful public purpose; and

WHEREAS, the Ed Brown Senior Center at Rancho Bernardo (Ed Brown Senior Center) has requested funding for facility upgrades for their center and for marketing and program materials for various senior fairs and events designed to encourage fitness among seniors; and

WHEREAS, the requested funding will allow the Ed Brown Senior Center to continue to provide facilities, events and opportunities to promote and encourage active senior living in the City of San Diego; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06, Community Projects, Programs and Services; and

WHEREAS, Council District Five recommends an allocation of \$8,300 to the Ed Brown Senior Center for the purposes set forth herein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation

described herein is made for a public purpose.

BE IT FURTHER RESOLVED, that the Council hereby waives Council Policy 100-06,

3(g), which provides: "An organization may not apply to receive funding for an event or program

which has already occurred, nor any capital improvement, goods, supplies, materials, or

equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to

negotiate and execute for and on behalf of the City, an Agreement with the Ed Brown Senior

Center at Rancho Bernardo, in an amount not to exceed \$8,300 for the project described herein.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$8,300 from the Community Projects, Programs and Services budget

Fund No. 100000, Cost Center 1105110005, to provide funds for the above-referenced

agreement, contingent upon the City Comptroller first furnishing one or more certificates

certifying that the funds necessary for expenditure are, or will be, on deposit with the City

Treasurer.
