A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN AGREEMENT FOR UPGRADES AND TAKING RELATED ACTIONS REGARDING THE VIEWS WEST NEIGHBORHOOD PARK.

WHEREAS, the City wishes to provide accessibility upgrades at the Views West Neighborhood Park to comply with state and federal regulations; and

WHEREAS, funding was approved and is available from facilities benefit assessment funds, subject to Council approval; and

WHEREAS, the Natural Resources & Culture Committee recommended approval of this action on April 25, 2012; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:

- 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, a design-build agreement with 3-D Enterprises, Inc. for ADA upgrades to Views West Neighborhood Park, under the terms and conditions set forth in the Agreement, on file in the Office of the City Clerk as Document No. RR 307552.
- 2. That the Chief Financial Officer is authorized to reduce the Capital Improvement Program budget by deappropriating and returning to fund balance \$275,000 in Fund No. 400221, Park Views Estates Development Agreement Fund, CIP S-10031, Views West Neighborhood Park ADA Upgrades.
- 3. That in accordance with the annual appropriation ordinance, the Chief Financial Officer is authorized to increase the Capital Improvement Program budget in CIP S-10031, Views West Neighborhood Park ADA Upgrades, by \$275,000 and to appropriate and expend

an amount not to exceed \$275,000 from Fund No. 400083, Rancho Penasquitos Facilities Benefit

Assessment (FBA) Fund, solely and exclusively to provide funds for ADA and other

improvements for the Views West Neighborhood Park, provided that the Chief Financial Officer

furnishes one or more certificates demonstrating that the funds for this expenditure are, or will

be, on deposit in the City Treasury.

4. That in accordance with the annual appropriation ordinance, the Chief Financial

Officer is authorized to increase the Capital Improvement Program budget in CIP S-10031,

Views West Neighborhood Park ADA Upgrades, and to appropriate and expend an amount

not to exceed \$305,100 from Fund No. 600000, Grant Fund-Federal, City SD-PR-Views West

ADA-12, solely and exclusively to provide funds for the Views West Neighborhood Park,

provided that the Chief Financial Officer furnishes one or more certificates demonstrating that

the funds for this expenditure are, or will be, on deposit in the City Treasury.

5. That the Chief Financial Officer is authorized to expend an amount not to exceed

\$674,726 from CIP S-10031, Views West Neighborhood Park ADA Upgrades, consisting of

\$305,100 from Fund No. 600000, Grant Fund-Federal, and \$342,626 from Fund No. 400083,

Rancho Penasquitos Facilities Benefit Assessment (FBA), solely and exclusively to provide

funds for the above design-build contract, provided that the Chief Financial Officer furnishes one

or more certificates demonstrating that the funds for this expenditure are, or will be, on deposit in

the City Treasury.
