A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO REPEALING COUNCIL POLICIES 600-01, 600-02, 600-03, 600-05, 600-06, 600-07, 600-10, 600-14, 600-15, 600-18, 600-22, 600-26, 600-28, 600-32, 600-34, 600-36, 600-38, 600-39, 600-40, 600-42, AND 600-44 ALL RELATING TO PLANNING AND ZONING.

WHEREAS, the 600 Series of the Council Policies, entitled "Planning and Zoning" (600 Series) contains many policies created by the City during the 1970s and 1980s, a period of expansive development in the City's new northern and southern communities; and

WHEREAS, certain policies within the 600 Series pre-date or were intended to implement the 1979 Progress Guide and General Plan which is no longer in effect and/or were adopted prior to the adoption of the 2000 Land Development Code (LDC); and

WHEREAS, during the development of the 2008 General Plan and corresponding amendments to the LDC, certain policies within the 600 Series were incorporated into the 2008 General Plan or LDC amendments; and

WHEREAS, the Council Policy Working Group (Working Group), comprised of staff representatives of the Council President, Mayor, City Attorney, and IBA held several meetings with staff from Development Services to consider suggested amendments to or repealing certain council policies within the 600 Series; and

WHEREAS, the Working Group recommended repealing Council Policies 600-01, 600-02, 600-03, 600-05, 600-06, 600-07, 600-10, 600-14, 600-15, 600-18, 600-22, 600-26, 600-28, 600-32, 600-34, 600-36, 600-38, 600-39, 600-40, 600-42, and 600-44 as being outdated and, in some cases, contradictory to subsequently adopted City policies or regulations; and

WHEREAS, other policies within the 600 Series are being further reviewed for possible amendments or repeal in conjunction with anticipated amendments to other City policies or regulations, or through a separate review process; and


WHEREAS, on April 24, 2012, the Community Planners Committee voted 23-0-1 to support the repeal of Council Policies 600-01, 600-02, 600-03, 600-05, 600-06, 600-07, 600-10, 600-14, 600-15, 600-18, 600-22, 600-26, 600-28, 600-32, 600-34, 600-38, 600-39, 600-40, 600-42, and 600-44; and

WHEREAS, on May 16, 2012, the Rules, Open Government, and Intergovernmental Relations Committee voted unanimously to support staff recommendation and forward to the full City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that Council Policy 600-01, dated July 20, 1981; Council Policy 600-02, dated December 19, 1974; Council Policy 600-03, dated July 5, 1994; Council Policy 600-05, dated October 25, 1982; Council Policy 600-06, dated February 20, 1975; Council Policy 600-07, dated February 20, 1975; Council Policy 600-10, dated May 12, 1975; Council Policy 600-14, dated December 12, 2000; Council Policy 600-15, dated May 18, 1993; Council Policy 600-18, dated July 6, 1972; Council Policy 600-22, dated November 4, 1985; Council Policy 600-26, dated August 20, 1979; Council Policy 600-28, dated August 11, 1980; Council Policy 600-32, dated July 5, 1994; Council Policy 600-34, dated May 20, 1986; Council Policy 600-36, dated March 7, 1995; Council Policy 600-38, dated June 8, 1992; Council Policy 600-39, dated August 4, 1992; Council Policy 600-40, dated January 29, 1992; Council Policy 600-42, dated November 26, 1996; and Council Policy 600-44, dated May 4, 2002 are hereby repealed.

BE IT FURTHER RESOLVED, that the City Clerk is instructed to update the Council Policy Manual to reflect that Council Policies 600-01, 600-02, 600-03, 600-05, 600-06, 600-07, 600-10, 600-14, 600-15, 600-18, 600-22, 600-26, 600-28, 600-32, 600-34, 600-36, 600-38, 600-39, 600-40, 600-42, 600-44 have been repealed.
