A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN AGREEMENT WITH D-MAX ENGINEERING, INC. FOR STORM WATER INSPECTION SERVICES.

WHEREAS, the City's Municipal Storm Water Permit (San Diego Regional Water Quality Control Board Order No. R9-2007-0001) requires the City to inspect approximately 5,000 industrial and commercial facilities per year and approximately 500 Structural Treatment Control Best Management Practices (Structural BMPs) per year; and

WHEREAS, on April 9, 2012, the San Diego Regional Water Quality Control Board issued an administrative draft of the forthcoming version of the City's Storm Water Permit, expected to be adopted in approximately December 2012, which includes substantially similar inspection requirements; and

WHEREAS, in January 2012, the Transportation & Storm Water Department issued a Request for Proposals for storm water inspection services with guidance from the Purchasing & Contracting Department, and based on the rating criteria, the selection panel determined D-Max Engineering, Inc. to be the highest qualified firm; and

WHEREAS, the proposed services would be for Fiscal Year 2013 with options to extend the contract for four additional one-year terms; and


WHEREAS, the Natural Resources and Culture Committee recommended approval of this action on June 27, 2012; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to enter into an agreement with D-Max Engineering, Inc. for storm water inspection services for the Industrial, Commercial, and Structural BMP Inspection Programs as required by the Municipal Storm Water Permit on the terms and conditions as set forth in the agreement on file with the City Clerk as Document No. RR-\_\_\_\_\_.

2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$7,500,000 over five years from the General Fund (10000), Transportation & Storm Water Department (2116) to provide funds for the contract with D-Max Engineering, Inc. to perform storm water inspections, contingent upon the adoption of the Annual Appropriations Ordinance and, provided that the Comptroller furnish one or more certificates demonstrating that the funds necessary for expenditure are, or will be, on deposit in the City Treasury.
