A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A MEMORANDUM OF UNDERSTANDING WITH REHRIG PACIFIC COMPANY FOR AUTOMATED REFUSE, RECYCLING, AND GREENERY COLLECTION CONTAINERS ON AN ASNEEDED BASIS.

WHEREAS, the City provides approved automated containers to residents for refuse, recycling, and greenery collection services furnished by City forces; and

WHEREAS, in March 2008 by Resolution No. R-303445, the Council authorized an agreement with Rehrig Pacific Company (Rehrig) to provide such containers to the City asneeded through November 2011, under a cooperative procurement contract awarded by the City of Los Angeles after a competitive bidding process; and

WHEREAS, the City of Los Angeles has recently exercised its final option to renew its automated container contract with Rehrig for an additional five years, and the City wishes to "piggyback" on the City of Los Angeles contract, pursuant to the terms and conditions of a new memorandum of understanding between the City and Rehrig; and

WHEREAS, the City estimates it will require about 30,000 new containers in Fiscal Year 2013 at an estimated cost of \$1,650,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, an agreement with Rehrig Pacific Company to furnish automated refuse, recycling, and greenery containers to the City on an as-needed basis from date of contract execution through November 30,

2016, and under the terms and conditions set forth in the Memorandum of Understanding, on file with the City Clerk as Document No. RR-307581.

2. That the Chief Financial Officer is authorized to expend an amount not to exceed the amount budgeted per Fiscal Year from General Fund No. 100000, Automated Refuse Container Fund No. 200302 (refuse containers), and Recycling Fund No. 700048 (recycling and greenery containers), to provide funds for the above Memorandum of Understanding, contingent on the adoption of the Annual Appropriations Ordinance and funding being authorized in the budget for this purpose, and provided that the City Comptroller first furnishes one or more certificates demonstrating that the funds necessary for the expenditure are, or will be, on deposit with the City Treasurer. It is estimated that approximately \$1,650,000 will be expended in Fiscal Year 2013.
