A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DECLARING THE COUNCIL'S INTENTION TO LEVY AND COLLECT ANNUAL ASSESSMENTS WITHIN EACH OF THE SPECIFIED CITY-MANAGED MAINTENANCE ASSESSMENT DISTRICTS FOR FISCAL YEAR 2013 AND NOTICING THE PUBLIC HEARING.

WHEREAS, the City formed each of the Maintenance Assessment Districts specified below pursuant to Article XIIIID of the California Constitution, the Proposition 218 Omnibus Implementation Act (California Government Code section 53750 *et seq.*), the Landscape and Lighting Act of 1972 (California Streets and Highways Code section 22500 *et seq.*), and the Maintenance Assessment Districts Ordinance (San Diego Municipal Code section 65.0201 *et seq.*); and

THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the City Council hereby declares its intention to levy and collect assessments within each of the above City-managed Maintenance Assessment Districts (MADs) in the City of San Diego for Fiscal Year 2013.

2. That the improvements and activities within these MADs generally consists of construction and maintenance of landscaped and paved medians, landscaped right-of-ways and slopes, open space, parks, ponds, flood control channels, monuments, decorative street lighting, decorative gates, community signage, banners, curbs and gutters, and sidewalks, as well as the provision of security services.

3. That the City-managed MADs are generally located in the following Community Planning Areas (CPAs):

4. That full and detailed descriptions of the improvements, the boundaries, and any zones therein, and the proposed assessments upon assessable lots and parcels of land within each of the MADs are available in the Engineer's Reports, on file with the City Clerk.

5. That the assessments for the following MADs are proposed to be adjusted downwards: Miramar Ranch North MAD and Pacific Highlands Ranch MAD.

6. That the assessments for the following MADs are proposed to be adjusted upwards, but not by more than the formula specified in the original Engineer's Report allows: Coral Gate, Kings Row & Village at Euclid - Zone 2, North Park, Ocean View Hills, Otay International Center, Stonecrest Village, Bay Terraces – Parkside, El Cajon Boulevard, First San Diego River Improvement Project, Gateway Center East, Hillcrest East/University Avenue, La

Jolla Village Drive, Peñasquitos East, Scripps-Miramar Ranch, Street Light District #1,  
Tierrasanta, University Heights, Washington Street, Torrey Highlands, and Webster/Federal  
Boulevard.


7. That the assessments for the remaining MADs are proposed to stay the same.

8. That notice is hereby given that on AUG 10, 2012 at 10:00 a.m., or as  
soon thereafter as it may be heard, in the Copper Room, Civic Concourse, located at 202 "C"  
Street, San Diego, California, is fixed as the time and place when and where any and all  
interested persons having a desire to be heard may appear and state their views, and/or submit  
written protests in compliance with California Streets and Highways Code section 22628.

9. That the City Clerk is hereby directed to give notice of the aforementioned public  
hearing by publication, pursuant to California Streets and Highways Code section 22626.
