A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR HIS REPRESENTATIVE TO APPLY FOR, ACCEPT, APPROPRIATE, AND EXPEND \$699,213 IN GRANT FUNDS FROM THE UNITED STATES DEPARTMENT OF JUSTICE UNDER THE 2011 EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT PROGRAM.

WHEREAS, the United States Department of Justice provides grant funds under the Edward Byrne Memorial Justice Assistance Grant (JAG) Program to state, local, and tribal law enforcement agencies to support a broad range of activities to prevent and control crime based on their own state and local needs and conditions; and

WHEREAS, grant funds can be used for state and local initiatives, technical assistance, training, personnel, equipment, supplies, contractual support, and information systems for criminal justice, including for any one or more of the following purpose areas: (1) law enforcement programs; (2) prosecution and court programs; (3) prevention and education programs; (4) corrections and community corrections programs; (5) drug treatment and enforcement programs; (6) planning, evaluation, and technology improvement programs; and (7) crime victim and witness programs (other than compensation); and

WHEREAS, the City of San Diego (City) and the County of San Diego (County) applied for joint allocation of grant funds under the 2011 JAG Grant; and

WHEREAS, the City is the fiscal agent for receipt of the funds; and

WHEREAS, the City and County are eligible for a joint allocation of \$699,213, with the City to receive \$553,817 and the County to receive \$145,396; and

WHEREAS, the City will enter into an agreement with the County to jointly manage the funds; and

WHEREAS, the City intends to use the 2011 JAG Grant funds to purchase equipment for its police department, and the new technology will provide officers with effective urban crime fighting tools; and

WHEREAS, the County will use the 2011 JAG Grant funds to support the salary of staff assigned to the Gang Suppression and Adult Drug Court programs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his representative is authorized, for and on behalf of the City, to apply for, accept, appropriate, and expend \$699,213 in grant funds from the 2011 JAG Grant, including any amendments, extensions, renewals, or subsequent funding for a period of up to five years, provided funding is made available by the U.S. Department of Justice, for the purpose of implementing the JAG Grant Program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept, appropriate, and expend \$699,213 in grant funds from the 2011 JAG Grant, including any amendments, extensions, renewals, or subsequent funding for a period of up to five years, provided funding is made available by the U.S. Department of Justice, for the purpose of implementing the JAG Grant Program.

BE IT FURTHER RESOLVED, that the Mayor or his representative is authorized, for and on behalf of the City, to enter into agreements with the County for the purpose of implementing the JAG Grant Program.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to allocate JAG Grant Program funds to the County.


BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to establish special interest-bearing fund for the grants, if required.

BE IT FURTHER RESOLVED, that the Chief of Police is authorized to administer and operate the JAG Grant Program.

BE IT FURTHER RESOLVED, that the Mayor or his representative, including the Chief of Police, is authorized to certify that the City will comply with all applicable statutory or regulatory requirements related to this grant program.
