A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE STATUS OF THE UNDERGOUNDING CONVERSION PROGRAM, AND CLARIFYING THE FUNDING SOURCE OF VARIOUS UNDERGROUND UTILITY DISTRICTS AND RELATED ACTIONS.

WHEREAS, the City of San Diego has both Rule 20 and Surcharge Programs to underground overhead utility facilities within the City; and

WHEREAS, Council Policy 600-08 requires the Mayor to bring before the City Council a master plan and allocation of projects for the underground conversion of overhead utility facilities each year; and

WHEREAS, City Council resolutions R-305143, R-305146, R-305148, R-305149, R-306562, R-306563, R-306564, R-306565, R-306566, R-306567, and R-306568 describing various utility underground utility districts specified that City of San Diego Undergrounding Surcharge Funds would be used to fund the projects; and

WHEREAS, the City will now utilize SDG&E Rule 20-A Funds to fund the above utility underground districts; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the report regarding the status of the City's Utility Undergrounding Program, including the status of all allocated underground conversion projects, as well as the status of expenditures and underground conversion accounts as provided by City staff in accordance with Council Policy [CP] 600-08, section (D)(3) is adopted.

- 2. That a revised 2009 Master Plan for 2011 CPUC Rule 20(A) projects and 2011 Surcharge projects in accordance with CP 600-08, section (B)(2), is adopted.
- 3. That in accordance with CP 600-08, section (B)(3)(b), an allocation of City of San Diego Surcharge funded underground conversion projects estimated at \$52,635,468.00 is approved.
- 4. That the list of proposed projects that meet the criteria of the California Public Utilities Commission Interim Order, Decision No. 73078, Case No. 8209, CPUC Rule 20-A, in accordance with CP 600-08, section (B)(3)(a) estimated at \$13,939,520.00 is approved.
- 5. The following underground utility districts shall be funded by SDG&E Rule 20-A Funds, as directed by California Public Utilities Commission Case 8209:
- a. San Vicente Street (San Vicente Court to Ashmore Lane) as described in
 R-305143, date of final passage July 31, 2009.
- b. Moraga Avenue (Moraga Court to Idlewild) as described in R-305144, date of final passage, July 31, 2009.
- c. Fanuel Street / Cardeno Drive (Archer Street to Tourmaline Street) as described in R-305146, date of final passage, July 31, 2009.
- d. Trojan Avenue (56th Street to 60th Street) as described in R-305148, date of final passage, July 31, 2009.
- e. 30th Street, Phase IIIA (Juniper Street to Ash Street) and Phase IIIB (A Street to K Street) as described in R-305149, date of final passage, July 31, 2009.
- f. Moraga Avenue, Phase II (Moraga Court to Monair Drive) as described in R-306562, date of final passage, January 28, 2011.

- g. Regents Road (Executive Drive to Regents Road) as described in R 306563, date of final passage January 28, 2011.
- h. Potomac Street (Calle Tres Lomas to Sea Breeze Drive) as described in R-306564, date of final passage, January 28, 2011.
- i. Sunset Cliffs Boulevard (Coronado Avenue to Newport Avenue) as described in R-306565, date of final passage January 28, 2011.
- j. Lincoln Avenue (30th Street to Wabash) as described in R-306566, date of final passage, January 22, 2011.
- k. Euclid Avenue (Euclid Avenue to University Avenue) as described in R-306567, date of final passage, January 28, 2011.
- 30th Street (Oceanview Boulevard to K Street) as described in R-306568, date of final passage, January 28, 2011.
- 6. That resolution R-305144, date of final passage July 31, 2009, is amended to correct the spelling of the word "IDLEWOOD" to read "IDLEWILD" within the resolution title.
