managed Maintenance Assessment Districts (MADs) is hereby approved as filed.

2. The continued levy and collection of assessments on parcels within the above

City-managed MADs is hereby authorized for Fiscal Year 2013 to pay a prescribed portion of

the costs of improvements and/or services as described in each Engineer's Report.

That the Chief Financial Officer is authorized to appropriate and expend the MAD 3.

funds, including the administrative fund, district operating funds, district capital funds, and

developer deposit funds associated with new assessment district formation activities for Fiscal

Year 2013 contingent upon approval of the Fiscal Year 2013 Appropriation Ordinance and

contingent upon the City Comptroller certifying that the funds necessary for expenditure are or

will be available.
