A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE UPDATED ENGINEERS REPORTS FOR THE CITY-MANAGED MAINTENANCE ASSESSMENT DISTRICTS, AUTHORIZING THE CONTINUED LEVY AND COLLECTION OF ASSESSMENTS FOR FISCAL YEAR 2013 WITHIN THE CITY-MANAGED MAINTENANCE ASSESSMENT DISTRICTS, AND AUTHORIZING THE APPROPRIATION AND EXPENDITURE OF FUNDS.

WHEREAS, after holding a public hearing and considering all protests, no majority protest exists with respect to any of the above City-managed MADs; and


WHEREAS, there are no proposed increases to the assessments, other than those authorized at the time of formation, including increases based on the San Diego Consumer Price Index; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that:

1. That the updated Fiscal Year 2013 Engineer's Reports for each of the City's City-managed Maintenance Assessment Districts (MADs) is hereby approved as filed.
2. The continued levy and collection of assessments on parcels within the above City-managed MADs is hereby authorized for Fiscal Year 2013 to pay a prescribed portion of the costs of improvements and/or services as described in each Engineer's Report.
3. That the Chief Financial Officer is authorized to appropriate and expend the MAD funds, including the administrative fund, district operating funds, district capital funds, and developer deposit funds associated with new assessment district formation activities for Fiscal Year 2013 contingent upon approval of the Fiscal Year 2013 Appropriation Ordinance and contingent upon the City Comptroller certifying that the funds necessary for expenditure are or will be available.
