A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO INITIATING AN AMENDMENT TO THE EAST ELLIOT COMMUNITY PLAN TO REDESIGNATE LAND FROM OPEN SPACE TO INDUSTRIAL.

WHEREAS, on August 29, 2011, Quail Brush Genco, LLC (Applicant) submitted an Application for Certification to the California Energy Commission to construct and operate a 100 megawatt gas-fired intermediate peaker plant on an approximately 22 acre parcel located on Sycamore Landfill Road, 0.6 miles north of Mast Boulevard (Property); and

WHEREAS, the Property's current land use designation is Open Space, which is inconsistent with the development and operation of an energy generation facility; and

WHEREAS, on July 19, 2012, the Planning Commission of the City of San Diego held a public hearing to consider a request to initiate an amendment to the East Elliot Community Plan adopted as Document RR-202550, and including its subsequent amendments, to redesignate a portion of the Property from Open Space to Industrial; and

WHEREAS, the Planning Commission considered Report No. PC-12-027 as well as all maps, exhibits, evidence, and testimony; and

WHEREAS, the Planning Commission denied the initiation of the East Elliot Community Plan amendment on July 19, 2012 by a vote of 4-1-2; and

WHEREAS, the Land Use and Community Planning Element of the General Plan, Policy LU-D.8, allows an applicant to submit a request to the City Clerk for the City Council to consider the initiation if it is denied by the Planning Commission; and

WHEREAS, the City Council may initiate a community plan amendment by resolution

pursuant to the Land Use and Community Planning Element of the General Plan, Policy LU-D.9,

which recognizes the ability of the City Council to initiate a General Plan and community plan

amendment when direction is received through a vote of the City Council without demonstration

of meeting the initiation criteria to prepare a plan amendment; and

WHEREAS, on September 24, 2012, the Council of City of San Diego held a public

hearing to consider initiating an amendment to the East Elliot Community Plan; and

WHEREAS, the City Council has considered all maps, exhibits, evidence, and testimony;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that it hereby denies the

request to initiate an East Elliot Community Plan Amendment to redesignate a portion of the

Property from Open Space to Industrial; and

BE IT FURTHER RESOLVED, Council urges the Applicant to withdraw its Application

for Certification.
