WHEREAS, on June 21, 2012, the 2011-2012 San Diego County Grand Jury (Grand Jury) filed a report titled "City of San Diego 2010 Redistricting Commission" (Report) that requested a response from the City Council, Mayor and City Clerk; and

WHEREAS, under California Penal Code section 933(c), within 90 days after the filing of the report, each public agency which the Grand Jury reviewed, and about which it issued the Report, must comment to the Presiding Judge of the Superior Court on the findings and recommendations pertaining to matters under the control of the agency; and

WHEREAS, at the request of the Council President, the Presiding Judge of the Superior Court has extended the time for the Council to respond until November 1, 2012; and

WHEREAS, the Grand Jury examined several issues relating to the City's Redistricting Commission and its processes, focusing on the appointment process and staffing of the Commission, and requested that the Council respond to five findings and recommendations numbered 12-50, 12-51, 12-52 and 12-53 in the Report; and

WHEREAS, the Grand Jury also requested a response from the City Clerk and the Mayor to recommendations 12-54, 12-55, 12-56 and 12-57; and

WHEREAS, under California Penal Code section 933(c) the City Council is the governing body responsible for responding to recommendations directed to the City Clerk; and
