A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN  
DIXSIE FARLEY AND THE CITY OF SAN DIEGO

WHEREAS, on October 31, 2011, DIXSIE FARLEY, filed suit against the City of San Diego [City] alleging personal injuries arising out an injury she received on or about December 17, 2010. The suit is entitled *Dixsie Farley v. City of San Diego*; Case No. 37-2011-00097717-CU-PO-CTL[Litigation]; and

WHEREAS, the City Council in closed session on July 31, 2012, authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes:

1. Authorizing the sum of \$235,000.00 to be paid from the Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the above-captioned matter, San Diego Superior Court Case No. 37-2011-00097717-CU-PO-CTL.

2. Authorizing the Chief Financial Officer to appropriate and expend \$235,000.00 from the Public Liability Fund, Fund 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. Authorizing the Comptroller to issue a check in the amount of \$235,000.00 made payable to Dixsie Farley and her attorney of record Steven M. Boudreau, APLC.


