DATE OF FINAL PASSAGE OCT 25 2012

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO RATIFYING A FIVE-YEAR AGREEMENT WITH SAN DIEGO POLICE EQUIPMENT, AND AUTHORIZING EXPENDITURES OVER FIVE YEARS, IN FISCAL YEARS 2013 THROUGH 2017, FOR THE PURCHASE OF FIREARMS AMMUNITION.

WHEREAS, Bid No. 10025499-13J was competitively bid in Fiscal Year 2012, and in Fiscal Year 2013 a contract was awarded to San Diego Police Equipment to provide firearms ammunition to the San Diego Police Department (SDPD); and

WHEREAS, SDPD anticipates spending more than one million dollars over the life of the five-year contract; and

WHEREAS, the estimated expenditures for future fiscal years are based on current SDPD needs and include possible ten percent price increases, as provided for in the contract; and

WHEREAS, the City Council's authorization will ensure that SDPD can continue firearms training at the current levels for the safety of police officers and citizens; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the agreement with San Diego Police Equipment to provide ammunition to the SDPD range is hereby ratified.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$470,000 in Fiscal Year 2013, from the General Fund (100000) for the first year of the San Diego Police Equipment contract.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$517,000 in Fiscal Year 2014, from the General Fund (100000) for the second year of the San Diego Police Equipment contract, contingent upon adoption of the Fiscal Year 2014 Annual Budget Appropriation Ordinance, and upon the Chief Financial Officer certifying that the funds necessary for expenditure are or will be available.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$568,700 in Fiscal Year 2015, from the General Fund (100000) for the third year of the San Diego Police Equipment contract, contingent upon adoption of the Fiscal Year 2015 Annual Budget Appropriation Ordinance, and upon the Chief Financial Officer certifying that the funds necessary for expenditure are or will be available.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$625,570 in Fiscal Year 2016, from the General Fund (100000) for the fourth year of the San Diego Police Equipment contract, contingent upon adoption of the Fiscal Year 2016 Annual Budget Appropriation Ordinance, and upon the Chief Financial Officer certifying that the funds necessary for expenditure are or will be available.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$688,127 in Fiscal Year 2017, from the General Fund (100000) for the fifth year of the San Diego Police Equipment contract, contingent upon adoption of the Fiscal

Year 2017 Annual Budget Appropriation Ordinance, and upon the Chief Financial Officer certifying that the funds necessary for expenditure are or will be available.
