A RESOLUTION AUTHORIZUNG THE AMNDMENT OF THE CITY CLERK'S FISCAL YEAR 2013 FEE SCHEDULE AND THE CITY CLERK'S FEE RATEBOOK TO CORRECT THE FIRE-RESCUE DEPATRMENT'S CEDMAT FEE FROM \$213.50 PER INSPECTION TO \$213.50 PER HOUR

WHEREAS, in accordance with the City of San Diego's (City) user fee policy, Financial Management coordinated a comprehensive analysis of each General Fund departments' user fees during Fiscal Year 2012; and

WHEREAS, on May 29, 2012, this Council adopted the FY 2013 fee additions and adjustments described in Resolution R-307482 for the purpose of recovering costs incurred by the City in providing services, goods, regulation, or as otherwise permitted under Article XIIIA and XIIIC of the California Constitution; and

WHEREAS, the adjustments to departments' user fees that were approved by this Council were implemented on July 1, 2012; and

WHEREAS, subsequent to this Council adopting these fees, additional review of the FY 2013 Fee Schedule and Resolution R-307482 revealed that the Combustible, Explosive, and Destructive Material (CEDMAT) inspections user fee inaccurately represented the charge as "per inspection" instead of the correct "per hour"; and

WHEREAS, the intention of this resolution is to correct this error and authorize the amendment of the City Clerk's FY 2013 Fee Schedule and Fee Ratebook to accurately reflect inspection fees for CEDMAT; and

WHEREAS, the FY 2013 CEDMAT inspection user fee was developed with the intended purpose of functioning as a "per hour" rate and not as a "per inspection" rate for CEDMAT customers; and

WHEREAS, as part of the FY 2013 comprehensive user fee analysis, CEDMAT inspection revenue was expected to recoup approximately \$344,000 by charging the fee on a "per hour" basis; and

WHEREAS, this corrected approach meets the full cost recovery intent of this Council's user fee policy; NOW THEREFORE,

BE IT RESOLVED, that this Council authorizes the amendment of the City Clerk's FY 2013 Fee Schedule to change the Fire Rescue Department's CEDMAT inspection fee from \$213.50 per inspection to \$213.50 per hour.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to amend the City Clerk's Fee Ratebook to change the Fire Rescue Department's CEDMAT inspection fee from \$213.50 per inspection to \$213.50 per hour.

BE IT FURTHER RESOLVED, that this CEDMAT inspection fee amendment shall be effective upon adoption of this resolution.
