A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING FEE ADJUSTMENTS AND NEW
FEES FOR THE MIRAMAR LANDFILL.

WHEREAS, pursuant to San Diego Municipal Code section 66.0129(d), the Mayor is authorized to periodically establish and revise fees for the Miramar Landfill (Landfill), subject to City Council approval by resolution; and

WHEREAS, pursuant to San Diego Municipal Code section 66.0129(e), the Mayor is authorized to establish and disestablish exemptions and discounts from Landfill fees, subject to City Council approval by resolution; and

WHEREAS, in connection with the Environmental Services Department's Five-Year Financial Outlook for its enterprise funds and corresponding recommendations to address structural budget imbalances in the enterprise funds, the Mayor proposes fee adjustments and new fees for the Landfill, as set forth in Report to the City Council No. 12-104; and

WHEREAS, this item was heard at the Natural Resources & Culture Committee on September 19, 2012 and was forwarded to the City Council for consideration; and

WHEREAS, in accordance with Administrative Regulation 95.35 §5.1(d), ten days' notice to the public of the City's intention to modify these fees was given by publication in the *San Diego Daily Transcript* and fourteen days' notice was mailed to interested parties; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following fee adjustments and new fees for the Miramar Landfill are hereby approved:

1. An increase of \$3.00 per ton in the Standard Disposal Fee for all Weighed Loads delivered to the Landfill, effective July 1, 2014.
2. An automatic, annual rate adjustment for all Weighed Loads delivered to the Landfill, based on the Consumer Price Index (CPI) rounded up to the nearest \$1.00, calculated in accordance with the formula described in Report to the City Council No.12-104, effective July 1, 2015.
3. A fee of \$20.00 per load for acceptance of clean fill dirt at the Landfill and delegation of authority to the Mayor or his designee to adjust the fee based on the approved criteria set forth in Report to the City Council No.12-104, effective January 1, 2013.
4. A fee of \$20.00 per ton for acceptance of Construction and Demolition Inert (CDI) residue at the Landfill and delegation of authority to the Mayor or his designee to adjust the fee based on approved criteria set forth in Report to the City Council No.12-104, effective July 1, 2013.
5. Adjustments to Landfill Greenery tipping fees to more fully and accurately recover the costs of processing Clean Green Materials and Clean Wood Scrap, effective July 1, 2013, as follows:
 - (a) an increase of \$6.00 per ton for Businesses-City and \$3.00 per ton for Non-City Customers on Clean Green Material;
 - (b) a decrease of \$7.00 per ton for Businesses-City and \$10.00 per ton for Non-City Customers on Clean Wood Scrap;

(c) an increase of \$6.00 per ton for Businesses-City and \$3.00 per ton for Non-City Customers on Single Generator Food Waste;


(d) an increase of \$10.00 per ton for Businesses-City and \$7.00 per ton for Non-City Customers on Multi-Generator Food Waste; and

(e) an increase of \$10.00 per ton for Businesses-City and \$7.00 per ton for Non-City Customers on Automated Green Waste (Multi Generator).

6. Elimination of the disposal and/or processing fee exemption (including applicable special handling and administrative fees) and elimination of the AB 939 Recycling Fee exemption for nonprofit organizations, effective July 1, 2013.

BE IT FURTHER RESOLVED, that the above fee adjustments and new fees are statutorily exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines section 15273(a)(1) and 15273(a)(2) because they are for the purpose of meeting operating expenses and purchasing or leasing supplies, equipment or materials, respectively.
