A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO PROVIDE NEW STATE OF THE ART AUDIO-VISUAL IMPROVEMENTS FOR THE NEW CENTRAL LIBRARY AND AUDITORIUM; TO ACCEPT REIMBURSEMENT FROM SAN DIEGO UNIFIED SCHOOL DISTRICT AND SAN DIEGO GAS & ELECTRIC COMPANY FOR PROJECT RELATED EXPENSES; TO TRANSFER LIBRARY IMPROVEMENT TRUST FUND MONEY TO THE PROJECT TO REDUCE THE SAN DIEGO LIBRARY FOUNDATION CONTRIBUTION REQUIREMENT.

WHEREAS, construction of the New Central Library (Project), located between Park Boulevard, 11th Avenue and J Street began on August 1, 2010; and

WHEREAS, the nine story library Project provides numerous public amenities including public meeting rooms, terraces, roof gardens, public computers, broadband wireless internet, children's library, teen center, auditorium, special events room, art gallery, café, underground parking and separate auditorium and café; and

WHEREAS, the Library Department and City TV wish to provide additional state of the art audio visual amenities for the library and auditorium and identified additional funding (\$1,000,000) in Fund 200595 that will be appropriated into the Project this purpose; and

WHEREAS, these Audio-visual funds will be used to build a public, education and government access channel facility inside the new main library that will create and air programs on cable channels 19 (education), 23 (public access), and 24 (City TV, government access); and

WHEREAS, on April 19, 2010 the City Council approved a Lease Agreement with San Diego Unified School District (SDUSD) for the lease of the 6th and 7th floors to operate a charter school; and

WHEREAS, on June 28, 2010, the City Council approved R-305943 that authorized an additional expenditure of up to \$500,000 and increase to the New Central Library Capital Improvement Project (CIP) budget for SDUSD required architectural changes to the Project; and

WHEREAS, the original authorized amount of not-to-exceed \$500,000 was fully expended and SDUSD subsequently desires to make additional changes in an amount not to exceed \$250,000 for the new Downtown Charter High School scheduled to open 2013; and

WHEREAS, on December 10, 2003, the City of San Diego granted San Diego Gas and Electric Company (SDG&E) an Emergency Access and Maintenance Easement for an underground 69 KV line in concrete encasement running east-west in the vacated K Street public right-of-way between 11th and 12th Avenues; and

WHEREAS, during construction of the Auditorium, it was discovered that the 69 KV line is adjacent to the auditorium footings and in order to facilitate future maintenance and possible relocation of their transmission line, SDG&E requests the City install six new concrete encased conduits 10 feet north of the existing 69 KV line within their easement; and

WHEREAS, SDG&E agrees to reimburse the City for the extra work for an estimated amount not to exceed \$200,000; and

WHEREAS, in November 2003 (R-298602), the Hervey Family deposited \$750,000 into Fund 200369, Library Improvement Trust Fund, for the purpose of Library Construction; and

WHEREAS, the Hervey Family requests that the \$750,000 donation be appropriated to the San Diego New Central Library Project for library construction, thereby reducing the San Diego Library Foundation contribution requirement; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Chief Financial Officer (CFO) is authorized to increase the Fiscal Year 2013 Capital Improvements Program Budget in an amount not to exceed \$1,450,000 in CIP S-00799, San Diego New Central Library; \$200,000 in Fund No. 400264, Private and Others Contributions – CIP, \$250,000 in Fund 400003, San Diego Unified School District (SDUSD) and \$1,000,000 in Fund No. 200595, PEG fee (City TV); and

BE IT FURTHER RESOLVED, the CFO is authorized to appropriate and expend \$1,000,000, from Fund 200595, PEG fee (City TV), to CIP S-00799, San Diego New Central Library, for the purpose of providing audio visual improvement design and construction for the New Central Library and Auditorium, contingent upon the City Comptroller first certifying that funds are available, or will be, on deposit with the City Treasurer; and

BE IT FURTHER RESOLVED, that the CFO is authorized to accept, appropriate and expend up to \$250,000 in CIP S-00799, San Diego New Central Library, Fund No. 400003, SDUSD, for the reimbursement of the SDUSD required architectural modifications, contingent upon the City Comptroller first certifying that funds are, or will be, on deposit with the City Treasurer, and

BE IT FURTHER RESOLVED, that the CFO is authorized to accept, appropriate and expend up to \$200,000 in CIP S-00799, San Diego New Central Library Fund No. 400264, Private & Others Contribution-CIP, for the reimbursement of SDG&E required infrastructure, contingent upon the City Comptroller first certifying that funds are, or will be, on deposit with the City Treasurer; and

BE IT FURTHER RESOLVED, that the Mayor or his designee is authorized to execute a Change Order to the Construction Manager at Risk Agreement with Turner Construction

(R-2013-318)

Company for Construction Services for the New Central Library in the amount of \$950,000 for

the purposes of audio visual improvement design and construction for the library and auditorium,

contingent upon the City Comptroller first certifying that funds are, or will be, on deposit with

the City Treasurer; and

BE IT FURTHER RESOLVED, that the CFO is authorized to appropriate and expend

\$750,000 in Fund 200369, Library Improvement Trust Fund, to CIP S-00799, San Diego New

Central Library, for the purpose of completing the construction of the New Central Library and

reducing the San Diego Library Foundation contribution requirement, contingent upon the City

Comptroller first certifying that funds are, or will be, on deposit with the City Treasurer; and

BE IT FURTHER RESOLVED, that the CFO is authorized to de-appropriate \$750,000,

Fund 400693, New Central Library Contributions, from CIP S-00799,

San Diego New Central Library, for the purpose of reducing the San Diego Library Foundation

contribution requirement per the terms of the Contribution Agreement.
