A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$50,000 TO STAR/PAL FOR PROGRAM COSTS FOR STAR/PAL YOUTH CENTER PROGRAMS, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, entitled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by Resolution R-306903; and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural or recreational needs which serve a lawful public purpose; and

WHEREAS, STAR/PAL has requested funding for its youth center programs for crime prevention; and

WHEREAS, the requested funding will allow STAR/PAL to provide staff resources, in order to implement youth center enrichment and training programs for youth in the community aimed at crime prevention; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06, Community Projects, Programs and Services; and

WHEREAS, Council Districts One, Two, Three, Five, Six, Seven and Eight recommend an allocation to STAR/PAL for the purposes set forth herein, attributed as follows: Council District One - \$12,500; Council District Two - \$5,000; Council District Three - \$5,000; Council

District Five - \$10,000; Council District Six - \$5,000; Council District Seven - \$10,000; and

Council District Eight - \$2,500, for a total of \$50,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation

described herein is made for a public purpose.

BE IT FURTHER RESOLVED that the Mayor, or his designee, is authorized to

negotiate and execute for and on behalf of the City, an Agreement with STAR/PAL in an amount

not to exceed \$50,000 for the project described herein.

BE IT FURTHER RESOLVED that the Chief Financial Officer is authorized to expend

an amount not to exceed \$50,000 from the Community Projects, Programs and Services budget

Fund No. 100000, Cost Center 1101110001 for \$12,500; Cost Center 1102110002 for \$5,000;

Cost Center 1103110003 for \$5,000; Cost Center 1105110005 for \$10,000; Cost Center

1106110006 for \$5,000; Cost Center 1107110007 for \$10,000; and Cost Center 1108110008 for

\$2,500, to provide funds for the above-referenced agreement, contingent upon the City

Comptroller first furnishing one or more certificates certifying that the funds necessary for

expenditure are, or will be, on deposit with the City Treasurer.
