A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$100,000 TO SAN DIEGO WORKFORCE PARTNERSHIP FOR HIRE-A-YOUTH PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, entitled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by Resolution R-306903; and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural or recreational needs which serve a lawful public purpose; and

WHEREAS, San Diego Workforce Partnership has requested funding for the Hire-a-Youth program; and

WHEREAS, the requested funding will provide San Diego Workforce Partnership with initial start up costs needed to build the internal infrastructure required to convene stakeholders and coordinate ongoing and sustainable youth employment and work based learning activities; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06, Community Projects, Programs and Services; and

WHEREAS, Council Districts One, Two, Three, Four, Six, Seven, and Eight recommend an allocation of \$100,000 to the San Diego Workforce Partnership for the purposes set forth herein attributed as follows: Council District One - \$30,000; Council District Two - \$10,000; -PAGE 1 OF 3-

Council District Three - \$5,000; Council District Four - \$25,000; Council District Six - \$5,000;

Council District Seven - \$20,000; and Council District Eight - \$5,000, NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation

described herein is made for a public purpose.

BE IT FURTHER RESOLVED that the Mayor, or his designee, is authorized to

negotiate and execute for and on behalf of the City, an Agreement with the San Diego Workforce

Partnership in an amount not to exceed \$100,000 for the project described herein.

BE IT FURTHER RESOLVED that the Chief Financial Officer is authorized to expend

an amount not to exceed \$100,000 from the Community Projects, Programs and Services budget

Fund No. 100000, Cost Center 1101110001 for \$30,000; Cost Center 1102110002 for \$10,000;

Cost Center 1103110003 for \$5,000; Cost Center 1104110004 for \$25,000; Cost Center

1106110006 for \$5,000; Cost Center 1107110007 for \$20,000; and Cost Center 1108110008 for

\$5,000, to provide funds for the above-referenced agreement, contingent upon the City

Comptroller first furnishing one or more certificates certifying that the funds necessary for

expenditure are, or will be, on deposit with the City Treasurer.
