A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO EXECUTE A CONSULTANT AGREEMENT WITH MOORE, IACOFANO AND GOLTSMAN, INC. FOR THE EUCLID AVENUE AND NATIONAL AVENUE MASTER PLANS.

WHEREAS, the California Department of Transportation awarded a \$481,500 Environmental Justice Planning Grant to the City of San Diego for the Euclid Avenue and National Avenue Master Plans (Master Plans); and

WHEREAS, the Master Plans will address implementation, feasibility, and urban design issues associated with creating smart growth mixed-use settings and will incorporate roadway, sidewalk, and streetscape improvements to enhance multimodal mobility and safety for pedestrians, bicyclists, automobile drivers, and transit riders; and

WHEREAS, the Development Services Department completed interviews for the selection of a consultant to assist in completing the Master Plans and selected Moore, Iacofano and Goltsman, Inc. as a result of that process; and

WHEREAS, the City has awarded more than \$250,000 in contract awards to Moore, Iacofano and Goltsman, Inc.; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Mayor or his designee is hereby authorized to execute, for and on behalf of the City, an agreement with Moore, Iacofano and Goltsman, Inc. in the amount not to exceed \$424,932, which is on file in the Office of the City Clerk as Document No. RR
307883

, for the preparation of the Master Plans.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$183,922 from Fund 600001, Caltrans Environmental Justice Grant No. 1000367-2012, awarded for the Euclid Avenue Master Plan.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$198,860 from Fund 600001, Caltrans Environmental Justice Grant No. 1000361-2012, awarded for the National Avenue Master Plan.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$42,150 from Fund 100000, General Fund, for the Master Plans.
