A RESOLUTION DECLARING THE RESULTS OF THE MUNICIPAL GENERAL ELECTION HELD IN THE CITY OF SAN DIEGO ON NOVEMBER 6, 2012.

WHEREAS, a Municipal General Election was held in the City of San Diego on Tuesday, November 6, 2012, pursuant to the provisions of Ordinance No. O-20184 (New Series), adopted July 17, 2012, for the purpose of electing candidates to the offices of Mayor and Councilmember for District 1; and

WHEREAS, the San Diego County Registrar of Voters (the Registrar of Voters) has been canvassing the returns of the Municipal General Election, with a state deadline to complete the canvas by the close of business on December 4, 2012; and

WHEREAS, as of November 30, 2012 at 4:30 p.m., the Registrar of Voters issued results of the canvass of returns for all but approximately 7,500 mail and provisional ballots still to be counted; and

WHEREAS, the City Clerk has certified the results as of November 30, 2012 to the City Council; and

WHEREAS, declaring the results of the election as certified by the City Clerk is a ministerial act required by California Elections Code section 10263 and, therefore, is not subject to veto by the Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council finds and determines, pursuant to the provisions of section 27.0411 of the San Diego Municipal Code, as follows:

I.

The results of the canvass of the votes cast in the Municipal General Election held on Tuesday, November 6, 2012, as of the canvass provided to the public by the San Diego County Registrar of Voters at the close of business on Friday, November 30, 2012, and certified by the City Clerk, are as follows:

FOR THE OFFICE OF MAYOR (four-year term)

Bob Filner Carl DeMaio	received received	244,813 votes 52.48% 221,661 votes 47.52%
Total for Office of Mayor		466,474 votes 100.0%

Bob Filner is hereby declared to be elected to the Office of Mayor in the Municipal General Election.

FOR THE OFFICE OF COUNCIL DISTRICT NO. 1 (four-year term)

Sherri S. Lightner	received	31,557 votes 54.96%
Ray Ellis	received	25,863 votes 45.04%
Total for Office of Council District No. 1		57,420 votes 100.0%

Sherri S. Lightner is hereby declared to be elected to the Office of Council District 1 in the Municipal General Election.

II.

Upon the City Clerk's receipt of the final canvass provided by the Registrar of Voters, the City Clerk is directed to record the total number of votes cast in the City of San Diego, and the number of votes cast in each precinct for each candidate, in the Election Returns Book. The book is authorized and is considered to be a part of the record of this Council.

The City Clerk also shall make public the results of the canvass of the Municipal General Election by publication of a copy of this resolution.
