A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$15,000 TO THE URBAN LEAGUE OF SAN DIEGO COUNTY FOR THE GOLDEN PYRAMID SCHOLARS PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, on June 28, 2011, the Council of the City of San Diego (Council) adopted Council Policy 100-06, entitled "City Council Funding of Community Projects, Programs and Services" by Resolution R-306903; and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural or recreational needs which serve a lawful public purpose; and

WHEREAS, the Urban League of San Diego County (Urban League) has requested funding for FY 2013 for their Golden Pyramid Scholars Program, an umbrella academic excellence recognition program for participants of Project Ready, BE SMART and Youth Empowerment aimed at helping urban youth achieve academic excellence; and

WHEREAS, the requested funding will allow the Urban League to provide venues, vendor booths that provide educational resources for the youth participants, audio-visuals-video, and programs that include educational college readiness resources; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06, Community Projects, Programs and Services; and

WHEREAS, Council District 4 recommends an allocation of \$15,000 to the Urban

League for the purposes set forth herein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation

described herein is made for a public purpose.

BE IT FURTHER RESOLVED that the Mayor, or his designee, is authorized to negotiate

and execute for and on behalf of the City, an Agreement with Jacobs Center for Neighborhood

Innovation in an amount not to exceed \$15,000 for the project described herein.

BE IT FURTHER RESOLVED that the Chief Financial Officer is authorized to expend

an amount not to exceed \$15,000 from the Community Projects, Programs and Services budget

Fund No. 100000, Cost Center 1104110004, to provide funds for the above-referenced

agreement, contingent upon the City Comptroller first furnishing one or more certificates

certifying that the funds necessary for expenditure are, or will be, on deposit with the City

Treasurer.
