A RESOLUTION APPROVING THE STREET DAMAGE FEE
AND AMENDING THE CITY OF SAN DIEGO RATEBOOK

WHEREAS, the proposed Street Preservation Ordinance would rename the Excavation Fee to the Street Damage Fee; and

WHEREAS, the City has conducted a full evaluation of the costs and revenues associated with providing City of San Diego (City) services, in accordance with the California Constitution as well as the State Government Code, which authorize local jurisdictions to impose fees, charges, and rates in order to recover costs associated with provided services; and

WHEREAS, it is the policy of the City to establish fees to recover the costs of providing services in accordance with the City of San Diego Administrative Regulation 95.25 and Council Policy 100-05 "User Fee Policy;" and

WHEREAS, Administrative Regulation 95.25 encourages transferring specific fee schedules listed in the San Diego Municipal Code and Council Resolutions to the standardized Ratebook maintained by the City Clerk; and


WHEREAS, the City desires to amend the fee schedule for the Street Damage Fee to reflect current costs incurred by the City to maintain streets that have been damaged by excavation; and

WHEREAS, the Street Damage Fee is governed by Chapter 6, Article 2, Division 12, Section 62.1215 of the San Diego Municipal Code as modified by the Street Preservation Ordinance; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the schedule of Street Damage Fees as described in Attachment 7, is hereby approved and is to be effective beginning on July 1, 2013.

BE IT FURTHER RESOLVED, by the Council of the City of San Diego, that the schedule of Street Damage Fees as described in Attachment 8, is hereby approved and is to be effective beginning on July 1, 2014.
