A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ALLOCATING \$9,000 TO MANA DE
SAN DIEGO FOR FY13 HERMANITAS YOUTH
LEADERSHIP MENTOR PROGRAM, PURSUANT TO
COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF
COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06,
entitled "City Council Funding of Community Projects, Programs and Services" on June 28,
2011, by Resolution R-306903; and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and
uniform requirements for awarding funds to and contracting with non-profit organizations and
public agencies for one-time community, social, environmental, cultural or recreational needs
which serve a lawful public purpose; and

WHEREAS, Mana de San Diego has requested funding for FY2013 for its Hermanitas
Youth Leadership Mentor Program; and

WHEREAS, the requested funding will allow Mana de San Diego to purchase supplies
and equipment to support this "little sisters" one-on-one mentoring program that promotes higher
education, leadership development and peer support to Latinas between the ages of 12-18
enrolled in middle and high school; and

WHEREAS, it is the determination of the City Council that the above-described program
fits within the parameters of Council Policy 100-06, Community Projects, Programs and
Services; and


WHEREAS, Council District 8 recommends an allocation of \$6,000 and Council District
4 recommends an allocation of \$3,000, for an amount not to exceed \$9,000 to Mana de San
Diego for the purposes set forth herein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described herein is made for a public purpose.

BE IT FURTHER RESOLVED that the Mayor, or his designee, is authorized to negotiate and execute for and on behalf of the City, an Agreement with Mana de San Diego in an amount not to exceed \$9,000 for the project described herein.

BE IT FURTHER RESOLVED that the Chief Financial Officer is authorized to expend an amount not to exceed \$9,000 from the Community Projects, Programs and Services budget Fund No. 100000 as follows: \$6,000 from Cost Center 1108110008 and \$3,000 from Cost Center 1104110004, to provide funds for the above-referenced agreement, contingent upon the City Comptroller first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.


