AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXTENSION OF AGREEMENT WITH NATURE'S IMAGE, INC. FOR THE SAN CLEMENTE CANYON MITIGATION PROJECT PAST FIVE YEARS.

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of said City, Change Order No. 3 to the San Clemente Canyon Mitigation Project (Project) under the terms and conditions set forth in the document on file in the office of the City Clerk as Document No. OO-20252, which change order will extend the contract duration by 746 days at no additional cost.

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
