AN ORDINANCE OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING EXTENSION OF AGREEMENT  
WITH HABITAT RESTORATION SCIENCES FOR THE ROSE  
CANYON MITIGATION PROJECT PAST FIVE YEARS.

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,


BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of said City, change orders to the Rose Canyon Mitigation Project (Project), which change orders will extend the contract duration by 663 days at no additional cost and to further extend the contract to July 15, 2015 if such additional time is required in order to satisfy requirements of the applicable regulatory agencies.

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.


