

ORDINANCE NUMBER O- 20259 (NEW SERIES)

DATE OF FINAL PASSAGE MAY 24 2013

AN ORDINANCE AMENDING CHAPTER 2, ARTICLE 6,
DIVISION 16 OF THE SAN DIEGO MUNICIPAL CODE BY
AMENDING SECTION 26.1602 RELATING TO THE YOUTH
COMMISSION.

WHEREAS, the City of San Diego Youth Commission (Commission) is established in San Diego Municipal Code, Chapter 2, Article 6, Division 16, sections 26.1601 through 26.1605, with its duties and functions set forth in section 26.1605; and

WHEREAS, pursuant to Municipal Code section 26.1605, the Commission's duties include providing advice and recommendations directly to the Mayor, City Council, City Manager, and other City officials on issues affecting youth in the City of San Diego; and

WHEREAS, Municipal Code section 26.1602 provides that the Commission shall consist of eighteen members appointed by the Mayor and confirmed by the City Council, who serve without compensation, for two-year terms, and until a member's successor is duly appointed and confirmed; and

WHEREAS, Municipal Code section 26.1602 addresses how the eighteen members are to be appointed, including a provision that the Mayor shall appoint "two (2) members from the nominees provided by each member of the City Council" for the first sixteen members, and "two (2) additional members chosen by the Mayor," to bring the total to eighteen; and

WHEREAS, the Council has now expanded to nine members, with the swearing in of a new Ninth District Councilmember on December 3, 2012, and the Municipal Code requires an amendment to provide for nominees to the Commission from the new Council district; and

WHEREAS, the proposed amendments to Municipal Code section 26.1602 would increase the total number of Commission members by two, from eighteen to twenty, and also make minor clerical changes; and

WHEREAS, the proposed amendments to the Municipal Code will provide that the District 9 Council office will be represented on the Commission in the same manner as the rest of the Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That Chapter 2, Article 6, Division 16 of the San Diego Municipal Code is amended by amending section 26.1602, to read as follows:

§26.1602 Youth Commission Established

There is hereby created a City of San Diego Youth Commission (Commission), consisting of twenty members who shall serve without compensation. The members shall be appointed by the Mayor and confirmed by the City Council. The Mayor shall appoint two members from the nominees provided by each member of the City Council, and two additional members chosen by the Mayor. Vacancies shall be filled in the same manner. Members shall serve two-year terms, and each member shall serve until a successor is duly appointed and confirmed. No member shall serve more than two consecutive terms. The expiration date of all terms shall be July 1. Members of the Commission shall be residents of the City of San Diego between the ages of 14 and 22. If any member of the Commission reaches the age of 23 while serving on the Commission, the appointment of that member shall expire the following July 1. The Mayor shall designate a Chair and a Vice Chair from among the members of the Commission.

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
