DATE OF FINAL PASSAGE JUN 18 2013

AN ORDINANCE OF THE COUNCIL OF THE CITY OF
SAN DIEGO TO AUTHORIZE THE EXECUTION OF THE
NINTH AMENDMENT TO THE AGREEMENT WITH A JOINT
VENTURE BETWEEN ROB WELLINGTON QUIGLEY
ARCHITECTS, INC., AND TUCKER SADLER ARCHITECTS,
INC., FOR ADDITIONAL DESIGN SERVICES FOR THE NEW
CENTRAL LIBRARY

WHEREAS, construction of the New Central Library (project), located between Park Boulevard, 11th Avenue, and J Street began on August 1, 2010; and

WHEREAS, the nine story library Project provides numerous public amenities including public meeting rooms, terraces, roof gardens, public computers, broadband wireless Internet, children's library, teen center, auditorium, special events room, art gallery, underground parking, and separate auditorium and café; and

WHEREAS, to achieve the Library's educational mission, state-of-the-art audio-visual improvements will be incorporated into the library and auditorium; and

WHEREAS, this action provides for the design of the improvements that will bring all video cameras, stage lighting and controls, signal control systems, and digital displays up to modern technological standards as the specifications in the original drawings are nearly 10 years old; and

WHEREAS, this action will also provide funding to enhance the design for the informational technology infrastructure, including work to increase the server, electronic security, and wireless capabilities for the entire facility; and

WHEREAS, this action will also provide funds for design of the infrastructure for artwork, such as providing additional power and data for display of electronic art, as well as standard wall mounted art in the Art Gallery and the elevator recesses; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized and directed to execute, for and on behalf of said City, the Ninth Amendment to the Joint Venture Contract with Rob Wellington Quigley Architects, Inc., and Tucker Sadler Architects, Inc., for the purpose of completing additional design services for the Project by and under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. OO 20266, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the Mayor shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

Section 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$93,900 from CIP S-00799, San Diego New Central Library, with \$50,000 from Fund No. 200595, PEG Fee (City TV), and then \$43,900 from Fund No. 400693, Central Library Contributions, for the purpose of executing funds for the above-referenced Ninth Amendment, provided that the City Comptroller first issues one or more certificates demonstrating that the funds necessary for this expenditure are, or will be, on deposit in the City Treasury.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
