AN ORDINANCE EXEMPTING A PROGRAM MANAGER POSITION IN THE FIRE-RESCUE DEPARTMENT FROM THE CLASSIFIED SERVICE

WHEREAS, on August 1, 2013 the Civil Service Commission approved a request to exempt one Program Manager position in the San Diego Fire-Rescue Department (SDFD) from classified service; and

WHEREAS, this Program Manager has significant responsibilities in the oversight of the City's regional Public Access Defibrillation (PAD) Program, known as "San Diego Project Heartbeat" (SDPFB); and

WHEREAS, as an SDFD program, SDPHB provides the City and greater community with PAD equipment, program oversight services, and CPR/Automated External Defibrillation (AED) training; and

WHEREAS, the Program Manager for SDPHB acts as the primary liaison between all public and private participants, directs marketing efforts, and is responsible for the financial performance of the program; and

WHEREAS, the Program Manager oversees the compliance of the City's contracted AED partner established through the City Corporate Partnership Department; and

WHEREAS, this Program Manager's key duties of SDPHB advocacy and community relations are conducted in coordination with the SDFD Public Information Officer, the City's contracted City ambulance provider, and the Mayor's Office via the Fire Chief; and

WHEREAS, San Diego Charter (Charter) section 117(a)(17) states that the Unclassified Service shall include "[m]anagerial employees having significant responsibilities for formulating or

administering departmental policies and programs. Each such position shall be exempted from the Classified Service by ordinance, upon the initiation of the appropriate appointing authority and after receiving the advisory review and comment of the Civil Service Commission and the approval of the City Council"; and

WHEREAS, on August 1, 2013, upon review of the duties and responsibilities of the Program Manager position, as provided by SDFD Fire Chief, the Civil Service Commission determined that the position meets the standard set forth in Charter section 117(a)(17) to be placed in the Unclassified Service; and

WHEREAS, the finding of the Civil Service Commission is set forth in a memorandum dated August 6, 2013, from Hadi Dehghani, Personnel Director, to the Honorable Council President and City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Council has received and reviewed a Memorandum from Personnel Director Hadi Dehghani, dated August 6, 2013, which documents that, on August 1, 2013, the City's Civil Service Commission reviewed and favorably commented on a proposal from the Fire-Rescue Department Fire Chief to exempt from the City's Classified Service a Program Manager in the Fire-Rescue Department, who will be responsible for overseeing the City's Public Access Defibrillation Program, acting as this program's public liaison, and directing the program's marketing efforts.

Section 2. That pursuant to Charter section 117(a)(17), with the Civil Service Commission's review and approval, the Council now exempts from the Classified Service and declares to be in the Unclassified Service of the City a Program Manager in the Fire-Rescue Department, performing the duties set forth in the June 13, 2013 Memorandum from Personnel Director Hadi Dehghani to the Honorable Council President and City Council.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been available to the City Council and the public a day prior to its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
