AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF AMENDMENT NO. 2 TO THE COOPERATIVE AGREEMENT WITH CALTRANS FOR THE CARROLL CANYON ROAD EXTENSION PROJECT.

WHEREAS, in 2009, the City entered into a cooperative agreement with Caltrans for the preparation of environmental documents for the Carroll Canyon Road Extension Project (Project); and

WHEREAS, under the same agreement, the City committed to a one-time lump sum amount of \$11,700,000 for the design and construction of the Project; and

WHEREAS, the City transferred City-owned land parcels to the State for the Project; and

WHEREAS, Amendment No. 2 to the Cooperative Agreement with Caltrans will extend the expiration date of the agreement from December 31, 2013 until the City and Caltrans have agreed the scope, cost, and schedule commitments have been met or until 5 years from the adoption of this ordinance, whichever is earliest; NOW, THEREFORE,

BE IT RESOLVED, that the Council President or his designee, in his capacity under Charter section 265(i), is authorized to execute Amendment No. 2 to Cooperative Agreement with Caltrans for the purpose of extending the contract completion date in CIP S-00841, Carroll Canyon Road Extension Project at no additional cost to the City.

BE IT FURTHER RESOLVED, that a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

BE IT FURTHER RESOLVED, that this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
