A RESOLUTION OF THE COUNCIL OF THE CITY  
OF SAN DIEGO AUTHORIZING FUNDING FOR  
THE REPAIR OF COASTAL BLUFF EROSION ON  
MIDWAY STREET.

WHEREAS, after erosion to the coastal bluff along Midway Street in Birdrock from the 2004-2005 storm season necessary repairs were needed; and

WHEREAS, the City received additional funding for the repairs in the amount of \$63,882.65 per the Settlement and Mutual Release Agreement signed by the City and Webcor Corporation, LP d/b/a Webcor Builders, La Jolla View Ltd. LLC, and Baratt American; and

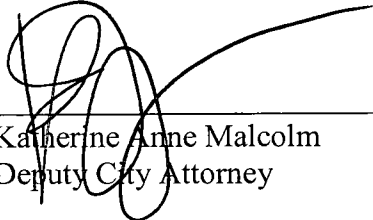
WHEREAS, on February 6, 2013, the Land Use & Housing Committee heard this item and recommended approval; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that in accordance with the annual appropriation ordinance, the Chief Financial Officer is authorized to amend the Fiscal Year 2013 Capital Improvements Program budget to increase S-12005, Midway Street Bluff Repair, by the amount of \$63,882.65.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$63,882.65 from Fund No. 400264, Private and Other Contributions to CIP, CIP S-12005, Midway Street Bluff Repair, solely and exclusively to provide design services for the repair of the eroded coastal bluff at the west end of Midway Street.

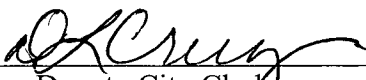

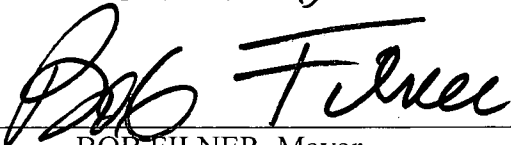
