A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ADOPTING THE ADDENDUM TO NEGATIVE
DECLARATION FOR THE SOUTH SAN DIEGO RECYCLING
MARKET DEVELOPMENT ZONE RE-DESIGNATION.

WHEREAS, on December 1, 2012, the City of Chula Vista, as Lead Agency under the California Environmental Quality Act of 1970, as amended (CEQA), has prepared or caused to be prepared and adopted an Addendum to the City of San Diego's Negative Declaration No. SCH 2002111114, LDR 42-0906, PTS 5498 (Addendum), for the South San Diego Recycling Market Development Zone (RMDZ) re-designation and expansion project, that finds that the project will result only in minor technical changes or additions to the Negative Declaration; and

WHEREAS, the Council as a Responsible Agency under CEQA has reviewed and considered the information in the Addendum to Negative Declaration adopted by the City of Chula Vista and finds that the RMDZ re-designation and expansion project will not have a significant impact on the environment; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Addendum to Negative Declaration, No. SCH 2002111114, LDR 42-0906, PTS 5498, dated December 1, 2012 for the South San Diego Recycling Market Development Zone re-designation and expansion project, on file in the Office of the City Clerk, has been completed in compliance with the California Environmental Quality Act of 1970 (California Public Resources Code section 21000 et seq.), as amended, and State guidelines thereto (California Code of Regulations section 15000 et seq.).

BE IT FURTHER RESOLVED, that the Addendum to Negative Declaration reflects the independent judgment of the City of San Diego as a Responsible Agency and that the information contained in the Addendum has been reviewed and considered by this Council prior to its approval of the application for the re-designation and expansion of the South San Diego Recycling Market Development Zone.
