A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO APPOINTING THE FISCAL YEAR 2014 ADVISORY BOARDS FOR THE BUSINESS IMPROVEMENT DISTRICTS.

WHEREAS, the City Council, in accordance with the Parking and Business Improvement Area Law of 1989 (California Streets and Highways Code sections 36500, et seq.) and City Council Policy 900-07, wishes to continue the promotional activities of eighteen Business Improvement Districts identified below ("Districts") in the City of San Diego; and

WHEREAS, California Streets and Highways Code section 36530 and Council Policy 900-07 require the City Council to appoint a business or merchants association ("Association") for each of the Districts as an advisory board, which among other things, provides recommendations to the City on the expenditure of assessment revenues; and

WHEREAS, Council Policy 900-07 requires the Association to be a non-profit corporation; and

WHEREAS, Diamond Business Association has applied for, but not yet received, determination of its non-profit status from the Internal Revenue Service; NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of San Diego, as follows:
