A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE FISCAL YEAR 2014 BUDGET REPORTS FOR THE SPECIFIED BUSINESS IMPROVEMENT DISTRICTS.

WHEREAS, the City Council, in accordance with the Parking and Business Improvement Area Law of 1989 (California Streets and Highways Code sections 36500, et seq.) and City Council Policy 900-07, wishes to continue the promotional activities of specified Business Improvement Districts in the City of San Diego; and

WHEREAS, California Streets and Highways Code section 36530 and Council Policy 900-07 require the City Council to appoint a business or merchants association ("Association") for each of the Districts as an advisory board, which among other things, provides recommendations to the City on the expenditure of assessment revenues; and

WHEREAS, Council Policy 900-07 requires the Association to be a non-profit corporation; and

WHEREAS, Diamond Business Association has applied for, but not yet received, determination of its non-profit status from the Internal Revenue Service; and

WHEREAS, in Resolution No. R-308071, the City Council waived that portion of Council Policy 900-07 requiring a District's Association to be a non-profit corporation to allow the Diamond Business Association to act as the Association for the Diamond Business Improvement District in Fiscal Year 2014 (i.e., July 1, 2013 through June 30, 2014); and

WHEREAS, the respective Fiscal Year 2013 Associations for each of the following Business Improvement Districts has submitted a report ("Budget Report") for Fiscal Year 2014, as required by California Streets and Highways Code section 36533: Adams Avenue; City Heights; College Area; Diamond; Downtown; East Village; El Cajon Boulevard Central; El Cajon Boulevard Gateway; Gaslamp; Hillcrest; La Jolla; Little Italy; Mission Hills; North Park; Ocean Beach; Old Town; Pacific Beach; and San Ysidro; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

- 1. The Fiscal Year 2014 Budget Report for each of the following Districts, as further described in paragraph 2 of this Resolution, is hereby approved: Adams Avenue; City Heights; College Area; Diamond; Downtown; East Village; El Cajon Boulevard Central; El Cajon Boulevard Gateway; Gaslamp; Hillcrest; La Jolla; Little Italy; Mission Hills; North Park; Ocean Beach; Old Town; Pacific Beach; and San Ysidro.
- 2. The full and detailed Fiscal Year 2014 Budget Reports for each of the above Districts, including a description of each District, the boundaries of each District (including any benefit zones), the proposed assessments to be levied upon the businesses within each District, as well as the improvements and activities to be undertaken within each District during Fiscal Year 2014, are on file and available for review at the Office of the City Clerk under the following document numbers:
