BE IT FURTHER RESOLVED, that the Chief Financial Officer, as delegated to Financial Management is authorized to appropriate and the Chief Financial Officer is authorized to expend an amount not to exceed \$4,000,000 over three years for the purpose of funding the

As-needed Agreement with Dudek, contingent upon the adoption of the Annual Appropriation

Ordinance for the applicable fiscal year, and the Chief Financial Officer first demonstrating that
the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$1,000 from CIP, WBS# S-00856, El Camino Real Bridge/Road Widening, Grant Fund 400264, is authorized, solely and exclusively for the purpose of providing funds for the Agreement.
