A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE CONTRACT WITH U.S. PEROXIDE, LLC FOR THE PROPRIETARY PROGRAMS FOR PEROXIDE REGENERATED-IRON SULFIDE CONTROL (PRI-SC/PRI-CEPT); AND TAKING RELATED ACTIONS.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the Mayor, or designee, is authorized to execute the contract with U.S. Peroxide, LLC, for the proprietary Peroxide Regenerated Iron – Sulfide Control Programs (PRI-SC/PRI-CEPT), Contract No. 4600001444, under the terms and conditions set forth in the document on file in the Office of the City Clerk as Document No. RR- 308108 (Contract), for an amount not to exceed \$4,858,000.

2. That the Mayor, or designee, is authorized to exercise each of the four options to extend the Contract for an additional year, under the terms and conditions set forth in the Contract, contingent upon the adoption of the Appropriation Ordinance for the applicable fiscal year and provided that the Chief Financial Officer first furnishes one or more certificates demonstrating that the funds are, or will be, on deposit with the City Treasury.

3. That the Chief Financial Officer is authorized to expend a total amount not to exceed \$29,307,035 from the Metro Sewer Utility Fund 700001, solely and exclusively to

provide funds for the first year of the Contract plus the four option years, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal years.




