A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$77,000 TO THE SAN DIEGO LGBT COMMUNITY CENTER FOR LGBT COMMUNITY: MENTAL HEALTH, YOUTH HOUSING, COMMUNITY PROGRAMS, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, entitled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by Resolution R-306903; and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural or recreational needs which serve a lawful public purpose; and

WHEREAS, the San Diego LGBT Community Center has requested funding for LGBT Community: Mental Health, Youth Housing, Community Programs; and

WHEREAS, the requested funding will allow the San Diego LGBT Community Center to provide direct program services to the LGBT community, such as mental health services, food distribution, health education, HIV testing and prevention, support and discussion groups, and other client advocacy services; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06, Community Projects, Programs and Services; and

WHEREAS, Council Districts 1, 2, 3, 5, 6, 7, and 8 recommend an allocation of \$77,000 to the San Diego LGBT Community Center for the purposes set forth herein attributed as follows: Council District 1 - \$10,000; and Council District 2 - \$10,000; and Council District 3 - \$16,000; and Council District 5 - \$15,000; and Council District 6 - \$10,000; and Council District 7 - \$1,000; and Council District 8 - \$15,000; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described herein is made for a public purpose.

BE IT FURTHER RESOLVED that the Mayor, or his designee, is authorized to Execute, for and on behalf of the City, an Agreement with the San Diego LGBT Community Center in an amount not to exceed \$77,000 for the project described herein, under terms and conditions set forth in the form City of San Diego Community Projects, Programs and Services FY 2013 City Council Allocations Agreement on file in the Office of the City Clerk as Document No. RR- 30811.3

BE IT FURTHER RESOLVED that the Chief Financial Officer is authorized to expend an amount not to exceed \$77,000 from the Community Projects, Programs and Services budget Fund No. 100000, Cost Center 1101110001 for \$10,000; and Cost Center 1102110002 for \$10,000; and Cost Center 1103110003 for \$16,000; and Cost Center 1105110005 for \$15,000; and Cost Center 1106110006 for \$10,000; and Cost Center 1107110007 for \$1,000 ; and Cost Center 1109110009 for \$15,000, to provide funds for the above-referenced agreement,

contingent upon the City Comptroller first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.




