A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ACCEPTING THE STATUS REPORT ON PLANNING APPLICATION FEE REVENUE FOR THE DOWNTOWN COMMUNITY PLAN AREA.

WHEREAS, on May 1, 2012, the City Council (Council) approved the Fee Schedule for the Downtown Community Plan area, which became effective July 1, 2012; and

WHEREAS, prior to July 1, 2012, the planning and development review activities of Centre City Development Corporation (newly named Civic San Diego) were financed through tax increment funds as part of the downtown redevelopment effort; and

WHEREAS, due to the passage of California Assembly Bill AB X1 26 (AB26) and the dissolution of redevelopment agencies, redevelopment tax increment funds were no longer available and in order for Civic San Diego to continue to provide development review services for the City of San Diego under its Operating Agreement, application review fees were necessary in order to provide funding for these functions; and

WHEREAS, in approving the Fee Schedule, the Council requested that Civic San Diego staff provide the Council with a status report on the revenues generated from the fixed-fee system after the first six-month period; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Planning Status Report on the Application Fee Schedule submitted by Civic San Diego for the Downtown Community Plan area, on file in the office of the City Clerk as Document No. RR- 308140, is hereby accepted.


