WHEREAS, on ______, 2013, the City Council adopted Resolution No. R- 308143, in which the City Council approved the FY 2014 Budget Reports for each of the specified Districts; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:
