A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE APPROPRIATION AND EXPENDITURE OF FUNDS FOR TRAFFIC CALMING ROAD HUMPS ON AVENIDA PLAYA VERACRUZ.


WHEREAS, residents of Avenida Playa Veracruz have requested the installation of traffic calming improvements on their street, and the Fire Department and the Tierrasanta Community Council have approved this request; and

WHEREAS, funding is available for this request from the developer agreement fund; NOW, THEREFORE

BE IT RESOLVED, by the Council of the City of San Diego, that in accordance with the Fiscal Year 2013 appropriation ordinance, the Chief Financial Officer is authorized to amend the Capital Improvement Program budget to increase CIP A-IL.00001, Traffic Calming, by \$32,813.

BE IT FURTHER RESOLVED, that the Mayor or his designee is authorized to appropriate and expend the amount of \$32,813 from Fund No. 400211, Lusk – General Traffic Improvements Development Agreement Fund, CIP A-IL.00001, Traffic Calming, solely and exclusively to install road humps on Avenida Playa Veracruz in the Tierrasanta community.


