A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING FUNDING FOR A WALKWAY FOR THE NORTH OCEAN BEACH GATEWAY PROJECT, PHASE II.

WHEREAS, in June 2012 by Resolution R-307495, the Council authorized grant funding for Phase II of the North Ocean Beach Gateway Project; and

WHEREAS, an ADA-compliant walkway is required for the project and funding is available from developer impact fees; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That in accordance with the Annual Appropriation Ordinance, the Chief Financial Officer is authorized to amend the Fiscal Year 2013 Capital Improvements Program budget to increase CIP S-12041, North Ocean Beach Gateway Project Phase II, by the amount of \$50,000.

2. That the Chief Financial Officer is authorized to transfer the amount of \$50,000 from Fund No. 400124, Ocean Beach Urban Community Development Impact Fee (DIF), to CIP S-12041, North Ocean Beach Gateway Project Phase II.

3. That the Chief Financial Officer is authorized to expend an amount not to exceed \$50,000 from CIP S-12041, North Ocean Beach Gateway Project Phase II, solely and exclusively to construct a walkway in compliance with the Americans with Disabilities Act.


