BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described herein is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is directed to execute, for and on behalf of the City, an Agreement with Sherman Heights Community Center dba Historic Barrio District CDC in an amount not to exceed \$2,000 for the project described herein, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-308174

BE IT FURTHER RESOLVED that the Chief Financial Officer is authorized to expend an amount not to exceed \$2,000 from the Community Projects, Programs and Services budget Fund No. 100000, Cost Center 1108110008, to provide funds for the above-referenced agreement, contingent upon the City Comptroller first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
